

DEAR SIR,

SORRY THAT SOME OF THE FOLLOWING TEXT DOESN'T FIT TO EVERYBODY: TO THE MEDIA, TO THE HOLLYWOOD STUDIOS (our life here is as in the "OLD WILD WEST"), TO SOME COURTS, TO TV-CANALS AS NEWS AND SO FORTH. COULD YOU LEAVE OUT THESE PARTS WHICH NOT ARE SUITABLE.

I have sent in June-august 2010 information to media in different countries about what kind, according to Lars, of Crimes and Damage the State of Spain / Organisation Judicial is doing to Spanish and foreign residents. An now the crimes against my wife and me multiplicities the hole time.

DURING 31 OF AUGUST AND 1 OF SEPTEMBER I HAVE SENT **26 EMAILS** TO EUROPE AND USA. BUT **ONLY ONE HAS INFORMED** THAT THEY HAVE RECEIVED MY EMAIL. NEARLY ALL THE MAILS HAS BEEN **RETURNED** FOR A REASON OR OTHER, SAME WITH HIEROGLYPHIC TEXT.

I UNDERSTAND THAT **THE SPANISH STATE DO NOT ACCEPT** MY HARMFUL AND TO MANY HIGH RANKING PERSONS DANGEROUS INFORMATION, INCLUDING MY NEW WEB PAGE.

- ◆ BECAUSE OF DE FOREGOING I STRONGLY BELIEVE THAT THE SPANISH STATE / JUDICIAL ORGANISATION **INTERCEPT MY NORMAL MAIL AND EMAILS AT LEAST BEFORE PROSECUTING ME IN THE COURT** AT 14 OF SEPTEMBER THIS YEAR (10-09-2010 AT 10:00). IN THIS PROSE'S I AND MY WIFE WILL WITH A GREAT POSSIBILITY LOOSE OUR HOME AND FARM. THIS IS CLEARED LATER IN THIS EMAIL.
- ◆ **THEY ARE PROSECUTING ME WITH FALSE ACCUSATIONS WRITTEN TO THE COURT OF OROTAVA**, MY WEB PAGE: www.larshjelt.com
MENÚ PRINCIPAL – Chantage para dividir finca – Cédula de Citación
- ◆ MY THREE (3) LAST **COMMUNICATIONS / PETITIONS OF HELP** TO THE **SPANISH KING AND ROYAL FAMILY** DATED 12-07, 16-08 and 31-08-2010 AND MAILED AS **EXPRESS AND CERTIFICATED** HAVE NOT BEEN ANSWERED UNTIL TO DAY (07-09-2010) – **MAYBE INTERCEPTED!**
- ◆ **THE COURT OF JUSTICE OF EUROPEAN COMMUNITIES, LUXEMBOURG** HAVE NOT UNTIL TO DAY (07-09-2010) RECEIVED OUR **EXPRESS AND CERTIFICATED** COMMUNICATION MAILED ON 30-08-2010!
- ◆ THE 2 OF SEPTEMBER 9 OF OUR MESSAGES TO SOME OF SPANISH TV-STATIONS A DAILY PRESS WERE LATER **RETURNED**, ALL TOGETHER WITHIN 5 SECONDS! The information we tried to send is the **following:**

DELINCUENCIA E INJUSTICIA EN ESPAÑA, SEGÚN LARS

AHORA Ustedes pueden Personalmente ver y Publicar como unos Contratistas con posible ayuda de una Falsa Escritura de Compraventa, la Tribunal de la Orotava y Ayuntamiento de la Victoria **intentan robar** un gran parte de nuestra Hogar y Finca al 14 de septiembre de 2010 a las 10:00 horas en Juzgado de Paz, la Victoria de Asentejo, Tenerife.

Esta misma Finca estaba comprado por Lars Hjelt prácticamente 3 veces, pero todavía después una Lucha de casi 2 Décadas, según Lars Hjelt, contra Injusticia Española no es nuestra.

Esta Injusticia es conocida en el Mundo Entero, 6 Continentes, 192 países.

NOW I SEND AND RESEND NEARLY THE ENTIRE EMAILS TROUGH ANOTHER COUNTRY.

Please, could you inform if my email has reach's you?

¿HOW COULD A CHAIN OF CRIMES HAVE SO MANY NEW "BRANCHES" WHICH CROW'S AT SUCH A SPEED?

If I and my Wife LOOSE OUR HOME AND FARM, someone might want to CLOSE our "Mouth".

If the Opposite LOOSE, we probably need but don't get any PROTECTION IN SPAIN.

The subject is: www.larshjelt.com: **Endless Urban Corruption, Criminality, Injustice and so forth in Spain during 1983-2010, according to Lars Hjelt.**

The subject is not very easy to find with my Web Direction because my Web page has been disturbed etcetera.

As an example **I DON'T HAVE IN SPAIN ANY RIGHTS TO MY OWN HOME. BECAUSE OF THE FIRST AND SECOND FALSIFIED / FALSE DEED BILL'S I CAN'T SELL MY PROPERTY, AS I WANT TO DO, OR A PART OF IT. But 40% of it was sold about two years ago without my knowledge and signature.**

Dear sire,

Are you interested to use the following notice and also of my whole declaration, witch can be seen in internet on pages www.larshjelt.com and public it or a part of it as an article?

My declaration is really **“breaking news”**. It's the first period (June-august 2010) informed to the general public after collecting 20 years of proofs against the criminality and unlawfulness of the judicial system of the Spanish state in the case of Lars Hjelt during 1982-2010.

AT FIRST SOME REPETITION FROM EARLIER INFORMATION'S:

Lot of foreign people, especially ingles, as well as Spanish citizens have lost their fortune in Spain buying construction land, houses, flats et cetera because of the unlawful / illegal and corrupt system we have here in Spain, according to my knowledge.

Important:

Reading the contents in www.larshjelt.com of “MENÚ PRINCIPAL: Falsificaciones en las Escrituras – Falsedades – Carpeta 5a” you will see **how easy is prepare a flagrant falsification of deed bills of sale in a public notary** (but totally impossible to rectify) in Spain - in a country of European Union.

I have myself lost my small farm place and the houses, I could say “several” times.

I have been fighting, according to my knowledge, against the state corruption in Spain more as 20 years with 17 worthless lawyers without any luck.

I bought (under marriage pact) my home with the farmland practically 3 times with 100% of my own money imported from other countries. But in spite of everything, I am the whole time continuing to loos more and can't continue longer alone because the time is theoretically running out; I am nearly 84 years old. The court of justice in Spain refuses to do anything certificated and informed in internet www.larshjelt.com

For safety reasons I have kept my wife (whose health, as mine is weakening during our hopeless years of fight) a side of my writings to the authorities.

Now the media have a good opportunity to observe “personally” what happens (sorry that I am hoping too much):

Have you any possibilities to send an observer to the “Juzgado de Paz” la Victoria de Acentejo, Tenerife at 14 of September 2010 at am 10:00 to see how the Spanish law / Spanish state in inters of two small contractors rob our home and farm place at the day mentioned. **A REPORTER COULD ALSO GET A LOT OF FIRST HAND INFORMATION WHAT REALLY ALSO HAPPENS IN SPAIN TO MANY INGLES CITIZENS.** This could be a great help to us and others who are suffering.

According to authorities on our side, we are going to loose because they believe that the whole procedure has been paid.

I and my wife visited some days ago the court in Orotava, Tenerife to find out what has been done with our 4 crime declaration's to their court and what is the actual situation.

They didn't know anything; their computer also not revealed / uncovered anything:

During a whole year it seems that **the Court of Orotava, Tenerife hasn't done anything**, which is the normal practise. – it's most possible among others, that the Spanish prosecutor ministry has denied any help for us, in spite of this new crime, please see: menu principal, **Carta Fiscalia: "3. xzd7"**.

- ◆ Our whole story exists in internet web-page but my internet pages have been during July-august **BADLY MIXED, AS MY COMPUTER, SEVERAL TIMES.**
- ◆ **ALSO OUR SPACE IN THE INTERNET WAS EMPTY A LONG TIME, VIOLATED OUR RIGHTS AND DAMAGED US SERIOUSLY.**
- ◆ AS AN EXAMPLE **SOME STRANGE EMAILS HAVE BEEN SENT THROUGH MY COMPUTER, MY E-MAIL'S HAS BEEN DISTURBED, 2 of September I HAD MORE AS 400 COPY'S OF MY ALBUMS ON MY HARD DISK and so forth.**
- ◆ I believe that the **second one**, (experts in this field) to whom I paid to insert my case in the Internet **HAVE BEEN ORDERED TO MAKE IT INCORRECTLY AND TO RETARD IT AS MUCH AS POSSIBLE** (at least until the court day 14-09-2010 at am 10:00).
- ◆ My first web-pages were difficult to open for normal persons and the first expert didn't want to do any of the alternations I asked, also didn't give me a receipt of € 250.00 I paid to him. We also had other several difficulties, so I terminated with him.
- ◆ **The second expert** was a kind person (director) and told that we are now in good hands. He also had good ideas. He informed that our new web-page will be fully in internet by an estimate in 15 working days. We started 16 of July and now we are in 5 of September!
- ◆ During the period 23 of July – 22 of August 2010 **I phoned him, without any benefit, about 86 times** (according to the bill of Telephone Company) **to make him hurry up with our web page – we were fighting for our home and future.** He gave me **ONLY** more as **18 false** promises. But he also continues to be a nice person and informs the whole time that I should not be worried.
- ◆ **NOW THE REALLY BIG PROBLEM IS** that my direction in internet (www.larshjelt.com), which has been given to the whole world (6 continents, 192 countries) is maybe not correct any more, at least at this moment. This old direction **directs** everyone who is using sign **"Internet Mozilla Firefox"** to a **falls and dangerously misleading web page:** "Lars Hjelt" **without** the most important certificates, statements and information. In the empty place of the missing statements is informed: **"TERMINADO" = BROUGHT TO END / CLOSED.** It's totally clear that nobody is going to search for the correct page with the same name "Lars Hjelt". With the first glance the two, inside totally different, pages have the same appearance.

- ◆ The persons who are looking at the above mentioned page do think that my case is solved and closed – so we are not getting any more help from the public and the media and might lose our farm and home, and the corrupt Spanish world win after nearly 20 years our battle against corruption, falsifications, crimes and so on in Spain.
- ◆ Using the **“Internet Mozilla Firefox”** sign the www.larshjelt.com which has been given to the whole world (6 continents, 192 countries) **does not direct straight** to my web page “Lars Hjelt”. (Could be that I am mistaking, due to my poor knowledge of Internet.)

In every case we must terminate with this person because among others, according to Lars, he lies and is dangerous to our future as long we live.

- ◆ He did enter against our order, **to us a secret, false “password” in three places** in our web page, so only he could make alternations to my text but I not. He may also wipe out my whole web page. **I, WHO OWN THE WEB PAGE AND WHO HAVE PAID FOR EVERY RIGHT,** could not, **without his permission,** take another person to clean up what wrong he had done.
- ◆ During the visit of this second expert at 20-08-2010 (3 hours) **he connected a memory stick for about 2 hours to my computer without asking me and without my permission** – this is a crime according to Spanish law. Later I noticed it but thought that he is only updating the files he had to insert in internet – **that was not the case;** he was most probably copying everything that I had on my hard disk.
- ◆ I believe that this person **has given valuable information to the Court of Orotava** and all the contra part's to make more possible to throw us to the “street” from our own home and farm (bought by my self practically 3 times). **The personal information (Bank accounts, Insurance values, information of Valuables, all kind of Personal Information and so forth)** he maybe has stolen from our hard disk and may also, **if this was his purpose,** direct thieves to our home. **There is no doubt that it didn't exist some purpose!**
- ◆ I informed (28.08.) to the person, that I will make a statement to the criminal police (Guardia Civil). He denied that he had done anything wrong. And maybe as an excuse he promised to make corrections in my web page and inserted immediately 2 a long time missing files to my web page. The both files are disagreeable to many officials and especially to the lawyer who wrote the untrue text to the court with intents to charge me and destroy my wife and me at 14-09-2010.
- ◆ I and my wife went at 3 of September 2010 at 12:00 to the **GUARDIA CIVIL BUT THEY DIDN'T ¿WANT? TO MAKE OUR CRIMINAL STATEMENT – ¿WHAT REALLY ARE THEIR DUTIES?**

- ◆ **I BELIEVE THAT THE WHOLE COURT OF JUSTICE / JUDICIAL SYSTEM OF SPAIN IS AGAINST US BECAUSE I HAVE NOT DURING ALL THIS, OVER 18 YEARS, ACCEPTED THEIR UNJUSTLY JUDGMENTS, HAVE CRITICIZED THEM, USED MANY OF THEIR OWN STATEMENTS AGAINST THEM IN MY FIGHT TO GET JUSTICE AND MY HOME BACK AND SO FORTH.**
- ◆ **WE CAN'T EXPECT ANY HELP FROM STATE OF SPAIN, WHICH IN ALL CASES HAS BEEN REFUSED 100% UNTIL TODAY!**

It's a small possibility that the censure is behind this all, but only the "Audiencia Nacional" can wipe out a web page.

- ◆ I believe that **the court of Orotava, Tenerife has given the orders to our second internet expert to intervene in our web-pages**, because they are going to charge me in their court 14-09-2010 at am 10:00. **This court has newer Dan anything else as brought to us endless disaster, but nothing to bring back our home.**
- ◆ Could also be the **Spanish General Prosecutor**, their letter, enclosed, with my comments: "3. xzd7"
- ◆ **The contractors**, according to me, also **have a great interest to pay bribes**. The other part is also the **Municipal Government**; which is to my knowledge on the contractor's side. (According to writings and TV panels **our town, La Victoria, has a badly corrupt name**). **The Municipal Government have also earlier tried to rob some parts of our farm.**

At this moment the correct but not totally finished web page can **MAYBE** be found, but **not very easily** to the normal Internet users, clicking the sign "**Internet Explorer**".
